

‘SENIOR’S CLUB’ PROMOTION
Sunday 1st August 2021 to Sunday 31st July 2022
TERMS AND CONDITIONS

1. Information on how to participate and Prizes form part of these Terms and Conditions. Participation in this “Senior’s Club” (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in Australian Eastern Standard time (AEST).

ELIGIBILITY

2. Subject to condition 3, this Promotion is only open to **Qld residents** aged 55 years or over.
3. The following are ineligible to participate: (i) employees of the Promoter or any of the Tenants or Retailers (including employees) in Morayfield Shopping Centre or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

PROMOTION PERIOD

4. This Promotion commences on 01/08/2021 and ends at 11.59pm AEST on 31/07/22 (“**Promotion Period**”).

HOW TO JOIN

5. Customers over the age of 55 can join the Senior’s Club by completing the application form from Centre Management Office at Morayfield Shopping Centre.
6. Once the form is presented to Centre Management Office customers will receive a Senior’s Club Discount Card. This will give members access to participating ‘Retailer Offers’. Customer are also required to select a “Prize Preference” as shown on the participation form. This is only an indication and customers must visit Centre Management Office to receive a gift as limits apply.

PARTICIPATION IN THE PROGRAM

7. The Promotion will be conducted at Morayfield Shopping Centre, 171 Morayfield Road, Morayfield, Qld, 4506 (“Participating Centre”). “Participating Retailers” (See Appendix 1) means the Retailers within the Participating Centre. The Promoter (in its sole discretion) has the right to add or remove from the list of Participating Retailers at any time.

- (a) To access benefits a valid date of birth must be entered against the members application form and the age of the member must be 55 years or older to qualify to join the Senior's Club.
 - (b) Senior's Club Memberships are valid for 12 months and must be renewed annually.
 - (c) Senior's Club benefits are not transferable, not redeemable for cash and are non-refundable. Membership can be revoked by Participating Centre at any time, in its sole discretion and without compensation, for any reason including but not limited to abuse or breach of any of the Terms and Conditions of the Promotion, any actions deemed by Participating Centre to be contrary to Participating Centre, the Promotion or the interests of its Members or Participating Retailers or in the case of fraud or misuse.
8. To receive a 'Gift' in this Promotion, eligible individuals must, during the Promotion Period, **be one of the first 1,012 customers** to undertake the following steps:
- (d) Complete a Senior's Club application form and present it to Centre Management Office at Participating Centre during the Promotion Period. A maximum of one (1) Gift may be claimed per person.
 - (e) Customers will have a choice from one of two gifts. A Prize Collection form will need to be completed and valid Identification shown. The form includes their full name (matching their valid Identification), signature and date.

RETAILER OFFERS

9. To qualify for any Retailer offers, you must present a Morayfield Shopping Centre Seniors Discount Card to any of the participating Retailers. Offers and discounts are only valid at Morayfield Shopping Centre stores. Offers may not be used in conjunction with any other offers. Discounts may not be valid on already discounted items. Special conditions may apply. Visit the individual store for further information. Offers are subject to change without notice. Offers are only valid over the Promotion Period.

LIMITS ON ENTRY

10. An eligible individual may participate once only in the promotion during the Promotional Period subject to and in accordance with the entry requirements. A maximum of one (1) Gift only may be claimed per person.

GIFTS AND LIMITS ON GIFTS

11. A total of 1,012 Gifts will be distributed during the Promotional Period and the below limits apply.
12. The Gifts per Promotional Period comprise:
 - (a) 262 Movie Tickets (valued at \$35 each) valid for use by a Senior for admission to any standard movie session (subject to seating availability) valid from 1st August to 31st October 2021 at BCC Morayfield. The Movie Ticket may not be utilised to book a seat online. The Movie Ticket Letter must be presented at the BCC Morayfield Box Office to book a seat. The ticket cannot be transferred, sold or exchanged for cash and is subject to all Birch Carol and Coyle Terms and Conditions. The Movie Tickets Total Prize Pool for the promotion duration is 262 with a value of \$9,170.00 inclusive of GST.
 - (b) 750 Muffin Break Muffin Vouchers valued at \$4.50 each. This voucher can only be used at Muffin Break Morayfield. It can be used for any muffin flavour (subject to availability at Muffin Break Morayfield). The Muffin Break Muffin Vouchers Total Prize Pool for the promotion duration is 750 muffins with a value of \$3,375 inclusive of GST.
13. Whilst stock of both Gifts is available, the participant may choose their Gift Preference. Once the total stock of either Gift is reached, then the alternate remaining gift (only) will be available to the participant.
14. The Promoter reserves the right to end the promotion prior to 31st July 2022.
15. If for any reason a participant does not take a Gift or any element of a Gift at the time stipulated, then the Gift or that element of the Gift will be forfeited and will not be redeemable for cash.
16. If either Gift (or part of any Gift) is unavailable due to reasons beyond the control of the Promoter, the Promoter at its discretion, reserves the right to substitute the Gift (or that part of the Gift) with a Gift to the equal value and/or specification, subject to any written directions from a regulatory authority.
17. The Gift, or any unused portion of the Gift, is not transferable or exchangeable and cannot be taken as cash

GENERAL

18. If there is a dispute as to the identity of a Participant, the Promoter reserves the right, in its sole discretion, to determine the identity the participant.

19. Participants consent to the Promoter using their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this promotion (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter.
20. The Promoter reserves the right, at any time, to verify the validity of Participants (including a Participant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the participation process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
21. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to COVID-19 Government directives, technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law to (a) disqualify any participant; or (b) subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate.
22. The Promoter reserves the right to alter these Terms and Conditions at any time and the Promoter's decision is final, and no correspondence will be entered into.
23. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("**Non-Excludable Guarantees**"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.
24. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury or health outcome; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c)

any Gift claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.

25. As a condition of accepting the Gift, the entrant must sign any legal documentation as and, in the form, required by the Promoter and/or Gift suppliers in their absolute discretion, including but not limited to a legal release and indemnity form.

PRIVACY

26. The Promoter collects personal information ("**PI**") in order to conduct the Promotion and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on providing this PI. The Promoter will also use and handle PI as set out in its Privacy Policy, which can be viewed at <https://www.morayfieldshoppingcentre.com.au/privacy-policy/>. In addition to any use that may be outlined in the Promoter's Privacy Policy, the Promoter may, for an indefinite period, unless otherwise advised, use the PI for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the entrant. The Privacy Policy also contains information about how entrants may opt out, access, update or correct their PI, how entrants may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with. All entries become the property of the Promoter. The Promoter will not disclose PI to any entity outside of Australia.
