TERMS AND CONDITIONS

Information on how to participate and Prizes form part of these Terms and Conditions. Participation in this “Win a Camping Adventure Pack” (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in Australian Eastern Standard time (AEST).

PROMOTIONAL PERIOD

1. The promotional period is from 8:00am on 1 March 2026 to 6:00pm on 29 March 2026. The promotional rewards app will be open to accept Participants 24 hours per day during the promotional period.

PARTICIPATION IN THE PROMOTION

2. By participating in the Promotion, the Participant agrees to these Terms and Conditions.
3. Information on all associated advertising and the Rewards App also forms part of these Terms and Conditions.
4. The Promotion will be conducted at Morayfield Shopping Centre during the Promotion Period.
5. To participate in the Promotion, the Participant must be an Eligible Person who makes an Eligible Transaction during the Promotion Period at any Participating Store only.
6. The following receipts are not valid receipts and therefore are ‘Non-Eligible Transactions’ for the purpose of the Promotion:
 - (a) receipt(s) from non-participating retailers and Excluded Retailers,
 - (b) receipt(s) recording bill payments, tobacco, pharmacy prescriptions, medical services, Australia Post expenditure (excepting gift lines) and gambling such as lotto and scratchies
 - (c) receipts recording redemption of gift card purchases, store credit, refunds and exchanges;
 - (d) ATM or EFTPOS receipts;
 - (e) credit card or bank statements;

- (f) receipts that the Promoter has reasonably determined to have been tampered with or have been obtained fraudulently or are a reprint of the original receipts;
7. Participants must make a purchase of \$50 or more in one transaction at one Participating store during the Promotional period.
 8. There is no limit on the number of times a Participant may participate in the Promotion during the Promotion Period, however **a Participant can only receive one Eligible Entry per receipt valued at \$50 or more each** during the promotional period.
 9. To enter the Promotion, the Eligible Person must during the Promotion Period:
 - (a) make an Eligible Transaction of \$50 or more in one transaction at one Participating Store
 - (b) Upload image of the Eligible Transaction receipt to the Morayfield Shopping Centre Rewards App (the Participant must be a member of the Rewards App before being able to enter), and
 - (c) fully complete the information required on the App when uploading the receipt which contains the Eligible Person's Total Spend, Suburb/postcode etc.
 10. The Promoter (in its sole discretion) has the right to add or to remove from the list of Participating Stores at any time.
 11. The Promotion is only open to Eligible Persons.
 12. The Promoter reserves the right, at any time, to verify the eligibility of any Participant (including a Participant's identity, age and place of residence) and to disqualify any Participant who does not comply strictly with these Terms and Conditions or who tampers with the entry process. Incomplete, indecipherable or illegible entries will be deemed invalid. If requested by the Promoter, a Participant must provide the Promoter with evidence of eligibility. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

15. The winner selection will take place on Wednesday 1 April 2026 at Morayfield Shopping Centre between 10am and 5pm. Winners do not need to be present for the draw.
16. The prize recipient must be 18 years of age or over.
17. The Promoter may, but is not obliged to, publish the results of the Promotion. By participating in the Promotion, the Participant gives their consent for their personal details to be published in the manner prescribed in this clause if they are the recipient of a prize.
18. A Participant claiming to be the prize recipient may be required to provide proof of identity and proof of purchase by way of a store receipt.
19. The Promoter's decision as to the recipient of a prize is final and binding and no correspondence will be entered into in relation to the conduct of the Promotion or otherwise.

OTHER GENERAL TERMS

20. All terms and conditions pertaining to the membership to and use of the Morayfield Shopping Centre Rewards App apply to this Promotion.
21. All Promotion entries are the property of the Promoter.
22. The prize recipient consents to the Promoter using their name, likeness, image and voice for an unlimited period and without remuneration for marketing and publicity use, if requested by the Promoter.
23. The Promoter Entities shall not be liable (including, without limitation, in negligence) for:
 - (a) any loss or damage whatsoever that is suffered (including, but not limited to, indirect or consequential loss); or
 - (b) any personal injury suffered or sustained, during the course of participating in this Promotion or using the prize, except for and to the extent that any liability cannot be excluded by law.

24. Each Participant indemnifies and keeps indemnified the Promoter Entities against all claims, losses, damages, costs and expenses suffered or incurred by the Promoter Entities or any third parties arising out of the breach of these Terms and Conditions by the Participant, the conduct of the Participant in the Promotion or the use of the Gift by the Participant.
25. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law and subject to any written directions from a regulatory authority (if any) to:
 - (a) disqualify any Participant; and/or
 - (b) modify, suspend, terminate or cancel the Promotion as appropriate.

PRIVACY

26. Under the *Privacy Act 1998* (Cth), the Promoter must tell Participants when it collects personal information about them and how it plans to use it. If a Participant chooses to enter or take part in the Promotion, the participant will be required to provide the Promoter with personal information about themselves such as the Participant's name, address, telephone number, email address, the store where the Eligible Transaction was made, how the Participant heard about the Promotion and whether they wished to receive information surrounding future promotions.
27. The Promoter will collect and use the information which the Participant has provided for the following purposes:
 - (a) carrying out the Promotion; and
 - (b) if the Participant has accepted to receive future promotional communications from the Promoter, carrying out marketing and promotions activities including, without limitation, sending newsletters or publications and/or other marketing and promotional material to the Participant about the Promotions or promotional events (whether or not undertaken by or about the Promoter or any other person or organisation) and supplying the information to contractors which assist the Promoter to do this.
28. By entering the Promotion, a Participant consents to the collection and use of his or her information in the manner outlined in these Terms and Conditions.
29. If a Participant would prefer that the Promoter does not use the Participant's details in the way outlined in these Terms and Conditions

and/or retain their details, the Participant should contact the Promoter on (07) 5499 4255.

30. A Participant has the right to access most personal information which the Promoter holds about the Participant. A Participant may contact the Promoter on (07) 5499 4255 to ask for access to the Participant's information, or if the Participant has a complaint concerning a Participant's information privacy. The Promoter may deny the participant's request for access in some circumstances. If the Promoter does this, it will tell the Participant why.
31. If a Participant considers that any information that the Promoter holds about the Participant is inaccurate or if at any time the Participant's details change, the Participant may contact the Promoter on (07) 5499 4255 and the Promoter will take reasonable steps to ensure that such information is corrected. The Promoter will take reasonable steps to keep personal information secure from misuse, loss or unauthorised use or disclosure.

DEFINITIONS

- **“Centre”** means Morayfield Shopping Centre, 171 Morayfield Road, Morayfield, Queensland, 4506.
- **“Eligible Entry”** means an entry which complies with the requirements stated in these Terms and Conditions.
- **“Eligible Person”** means an individual who:
 - is a resident of Queensland;
 - is over 18 years of age
 - is not a Non-Eligible Person; and
 - submits an Eligible Entry.
- **“Eligible Transaction”** means an Eligible Person must spend \$50 or more in one transaction at one Participating Store in Morayfield Shopping Centre during the Promotion Period.
- **“Non-Eligible Transactions”** The following receipts are not valid receipts and therefore are ‘Non-Eligible Transactions’ for the purpose of the Promotion:
