Participation in the Promotion

1. The promotional period is from 9:00am on 1 July 2026 to 9:00pm on 7 July 2026. The entry mechanism via the Facebook page for Morayfield Shopping Centre will be available 24 hours a day during the aforementioned time period.
2. By participating in the Promotion, the Participant agrees to these Terms and Conditions.
3. Information on all associated advertising and the entry form also forms part of these Terms and Conditions.
4. To participate in the Promotion, the Participant must be an Eligible Person who fulfills the required steps to enter.
5. To enter, participants must:
 - Visit the new look Woolworths at Morayfield Shopping Centre
 - Head to our social media competition post on Facebook
 - Comment and tell us what you love about the new look Woolies
 - Entrants must have a public Facebook or Instagram profile for their entry to be visible.
 - Multiple entries are permitted; however, the winner is only entitled to receive one (1) prize

The Promotion

6. The Promotion will be conducted at Morayfield Shopping Centre during the Promotion Period.

Eligibility

7. The Promotion is only open to Eligible Persons.

The following are ineligible to participate: (i) employees of the Promoter or any of the tenants or retailers in Morayfield Shopping Centre or any of the Promoter's agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

8. The Promoter reserves the right, at any time, to verify the eligibility of any Participant (including a Participant's identity, age and place of residence) and to disqualify any Participant who does not comply strictly with these Terms and Conditions or who tampers with the entry process. Incomplete, indecipherable or illegible entries will be deemed invalid. If requested by the Promoter, a Participant must provide the Promoter with evidence of eligibility. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

9. Each prize is \$100 Woolworths Gift Cards. There are ten prizes to be won.
10. The Prize is not transferable, refundable or exchangeable, no change will be given and cannot be taken as cash.

Winner will be required to collect prize from Centre Management, and Photo ID will be required upon collection.

12. Winners do not need to be present for the drawer.
13. The promotion is in no way sponsored, endorsed or administered by, or associated with Meta. Each entrant releases Meta from all liability associated with this competition. By entering, participants agree to be bound by these Terms.
14. If for any reason the winner does not claim the prize within 1 month of the draw, then the prize will be forfeited.
15. The prize recipient must be 18 years of age or over.
16. The Promoter may, but is not obliged to, publish the results of the Promotion. By participating in the Promotion, the Participant gives their consent for their personal details to be published in the manner prescribed in this clause if they are the recipient of a prize.

Other General Terms

20. All Promotion entries are the property of the Promoter.
21. The prize recipient consents to the Promoter using their name, likeness, image and voice for an unlimited period and without remuneration for marketing and publicity use, if requested by the Promoter.
22. The Promoter Entities shall not be liable (including, without limitation, in negligence) for:
 - (a) any loss or damage whatsoever that is suffered (including, but not limited to, indirect or consequential loss); or
 - (b) any personal injury suffered or sustained,during the course of participating in this Promotion or using the prize, except for and to the extent that any liability cannot be excluded by law.
23. Each Participant indemnifies and keeps indemnified the Promoter Entities against all claims, losses, damages, costs and expenses suffered or incurred by the Promoter Entities or any third parties arising out of the breach of these Terms and Conditions by the Participant, the conduct of the Participant in the Promotion or the use of the Gift by the Participant.
24. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law and subject to any written directions from a regulatory authority (if any) to:
 - (a) disqualify any Participant; and/or
 - (b) modify, suspend, terminate or cancel the Promotion as appropriate.

Privacy

25. Under the *Privacy Act 1998* (Cth), the Promoter must tell Participants when it collects personal information about them and how it plans to use it. If a Participant chooses to enter or take part in the Promotion, the participant will be required to provide the Promoter with personal information about themselves such as the Participant's name, address, telephone number, email address, the store where the Eligible Transaction was made, how the Participant heard about the Promotion and whether they wished to receive information surrounding future promotions.
26. The Promoter will collect and use the information which the Participant has provided for the following purposes:
 - (a) carrying out the Promotion; and
 - (b) if the Participant has accepted to receive future promotional communications from the Promoter, carrying out marketing and promotions activities including, without limitation, sending newsletters or publications and/or other marketing and promotional material to the Participant about the Promotions or promotional events (whether or not undertaken by or about the Promoter or any other person or organisation) and supplying the information to contractors which assist the Promoter to do this.
27. By entering the Promotion, a Participant consents to the collection and use of his or her information in the manner outlined in these Terms and Conditions.
28. If a Participant would prefer that the Promoter does not use the Participant's details in the way outlined in these Terms and Conditions and/or retain their details, the Participant should contact the Promoter on (07) 5499 4255.
29. A Participant has the right to access most personal information which the Promoter holds about the Participant. A Participant may contact the Promoter on (07) 5499 4255 to ask for access to the Participant's information, or if the Participant has a complaint concerning a Participant's information privacy. The Promoter may deny the participant's request for access in some circumstances. If the Promoter does this, it will tell the Participant why.
30. If a Participant considers that any information that the Promoter holds about the Participant is inaccurate or if at any time the Participant's details change, the Participant may contact the Promoter on (07) 5499 4255 and the Promoter will take reasonable steps to ensure that such information is corrected. The Promoter will take reasonable steps to keep personal information secure from misuse, loss or unauthorised use or disclosure.

Definitions

"Centre" means Morayfield Shopping Centre, 171 Morayfield Road, Morayfield, Queensland, 4506.

"Eligible Entry" means an entry which complies with the requirements of clause 6.

"Eligible Person" means an individual who:

- (a) is a resident of Queensland;
 - (b) is over 18 years of age
 - (c) is not a Non-Eligible Person; and
 - (d) submits an Eligible Entry via the Morayfield Shopping Centre Rewards App.
- (a) **"Eligible Transaction"** means an Eligible Person must spend \$50 or more in one transaction at one Participating Fashion Retailer.

Shopping Centre during the Promotion Period. For the avoidance of doubt, payment for services (e.g. electricity, gas, telephone), registrations (e.g. motor vehicle registration), premiums (e.g. insurance and

“Participating Store” means WOOLWORTHS inside Morayfield Shopping Centre – Woolworths store 2744.

“Promoter” means the Centre, Morayfield Shopping Centre, 171 Morayfield Road, Morayfield, Queensland, 4506.

“Promoter Entities” means the Promoter, all associated companies, advisors and agencies and all those entities’ personnel.
